Pre-Pay Your Fees and Save \$250

Owners of nominated sale yearlings and owners of Open Berths can pay \$1,200 on or before Dec. 1, 2025 (no 30-day grace period). This payment covers all fees through August 1, 2026, and will save you \$250 off the regular payment schedule (Savings exclude original \$50 nominating fee for sale horses or Open Berths). The only remaining payment for the Futurity is the \$1,000 trial entry.

* Available Open Berths not purchased by Los Alamitos Equine sale consignors or buyers by Dec. 1, 2025, can be purchased through PCQHRA by payment of \$400 by Dec. 31, 2025 (Includes original \$50 nominating fee / Dec. 1, 2025, sustaining payment of \$150 / \$200 penalty). Remaining sustaining payments and trial/entry fees are required to maintain eligibility for the Breeders Futurity. [Sale consignors/buyers are given priority to purchase un-optioned Open Berths for \$200. This priority extends to the number of horses they sold or purchased in the Los Alamitos Equine Sale] {\$50 fee charged for Open Berths that are transferred from one owner to a new owner}.

** A specific horse must be named to each berth before or with the April 1, 2026, payment. All holders of paid-up berths must show proof of ownership of the specific horse to be named to the berth with the April 1, 2026, payment. Unnamed berths expire April 1, 2026.

In addition to any other race condition(s) that may apply individually to the race, the eligibility of horses nominated to, entering into, and/or competing in the Futurity is expressly restricted, conditioned, and limited to those horses that have not been administered or which do not test positive for the presence of Clenbuterol, Albuterol, Zilpaterol, Ractopamine, any other beta-2 agonist, any ARCI Class 1 substance, any HISA S0 substance, and/or the metabolites or analogues of any of these substances, as detected in either pre-or post-race or out-of-competition test samples, whether conducted under testing authorized by the CHRB or pursuant to a contract between LARC and Pacific Coast Quarter Horse Racing Association (PCQHRA). LARC and the PCQHRA have adopted hair sample testing processes and procedures in order to ensure that this race and certain other specified races are conducted under conditions that further protect and enhance the integrity and fairness of Quarter Horse racing at LARC. Accordingly, all qualifiers (top ten) will be hair and blood tested, and may at the discretion of LAQHRA and/or LARC be urine tested by supervising track veterinarians within 72 hours after the trials, utilizing the UC Davis Equine Analytical Chemistry Laboratory. Any qualifying horse having a “positive” test in either pre-or post-race or out-of-competition test samples will be deemed ineligible, given a “non-time,” and not be permitted to start or run in the Futurity. Five or more additional horses (i.e. 11th - 15th fastest qualifiers) may also be tested with urine, hair, and/or blood samples. The decision of the LAQHRA Testing Committee and/or stewards in all such matters shall be final, and entries are accepted on the condition that those persons nominating, entering, and/or starting a horse agree to abide by the decisions of either or both. The State of California Business & Professions Code, Section 19668(a) states: 'On or after July 1, 1995, it shall be unlawful for any person to enter or accept the entry of a horse in a race upon which there is pari-mutuel wagering until two years after the horse's foaling date

NOMINATION FOR THE 2026 P.C.Q.H.R.A. BREEDERS FUTURITY (FOALS OF 2024)

OPEN BERTH: The buyer (excluding persons who directly or indirectly repurchase their own horse) and the consigning owner, will each receive an option to purchase a **TRANSFERABLE OPEN BERTH** for each horse bought or sold through the auction ring of the 2025 Los Alamitos Equine Sale for **eligible entrants**. For purposes hereof, the consigning owner of a horse will be the owner designated on the AQHA registration papers immediately prior to the time such horse is passed through the auction ring. There will be a **\$50 transfer fee** charged for each transfer of ownership on an Open Berth. Nomination and sustaining payments for Open Berths optioned by sale consignors and buyers are the same as those for yearlings who have passed through the sale ring (in addition to the option on Open Berths offered to consignors and buyers for each horse sold or purchased, consignors and buyers are given priority to purchase additional un-optioned Open Berths at this same price [\$200, the total of \$50 original nominating fee, plus \$150 sustaining payment due Dec. 1, 2024] in a number equal to the number of horses they sold or purchased at the 2025 Los Alamitos Equine Sale). Un-optioned berths not sold to consignors or buyers according to the above referenced guidelines, revert to PCQHRA, which has the right to sell them for \$400 (\$50 original nominating fee/\$150 sustaining payment due Dec. 1, 2025/plus \$200 penalty) to any other interested parties. **All holders of paid up Open Berths have until April 1, 2026, to name a horse to each eligible berth. Proof of ownership (the AQHA owner of record) must be provided prior to naming a horse to an Open Berth on or before April 1, 2026. If a horse is not named to an Open Berth by April 1, 2026, that berth becomes null and void.**

REPURCHASE AND NO BIDS: Should the horse which passed through the auction ring be repurchased or was bid for but not actually purchased, the consigning owner **will not be entitled to one Open Berth** for that horse which was repurchased or that did not receive a bid.

The undersigned represents that he/she and all persons for whom he/she is acting have read and are familiar with the Rules of Racing and the regulations of the California Horse Racing Board and the race meeting conditions and agree to be bound by and comply with the same and with the acts and decisions of the California Horse Racing Board and horse racing officials, and that all animals shall be subject to the same and to the acts and decisions of the race officials and agree to be bound by the following terms and conditions: All stable reservations and entries in stakes and all other races are received and accepted subject to all conditions, rules and regulations of the California Horse Racing Board, the Pacific Coast Quarter Horse Racing Association and the Track.

ELIGIBILITY, NOMINATION AND PAYMENTS

Nominations and eligibility are open to Quarter Horse foals of 2024 which are registered with the American Quarter Horse Association to P.C.Q.H.R.A. Supporting Members and: (a) Which qualify for and are entered, cataloged and offered for sale in the yearling session of the 2025 Los Alamitos Equine Sale; (b) Any registered Quarter Horse foal of 2024 (to be placed in a berth) owned by a buyer of a horse purchased at the horse sale provided the buyer is entitled to a berth; (c) Any registered Quarter Horse foal of 2024 (to be placed in a berth) owned by a consigning owner of a horse sold at the horse sale provided the seller is entitled to a berth; (d) Any registered Quarter Horse foal of 2024 (to be placed in a berth) owned by an individual qualifying under (b) or (c), or who has purchased an un-optioned Open Berth from PCQHRA or purchased a berth extended to owners of starters in trials for the 2025 PCQHRA Breeders Futurity.

Open Berths not purchased at the Los Alamitos Equine Sale by eligible consignors and/or buyers by Dec. 1, 2025, will revert back to PCQHRA, which retains the right to find a buyer for these Open Berths on or before Dec. 31, 2025. The cost for an Open Berth purchased by anyone other than a sale consignor or buyer, or the owner of a starter in trials for the 2025 PCQHRA Breeders Futurity, will be \$400 (\$50 original nominating fee/\$150 sustaining fee due Dec. 1, 2025/plus \$200 penalty). All remaining sustaining payments must be made to remain eligible until a horse has been named to an Open Berth on or before April 1, 2026. Open Berths not sold by Dec. 31, 2025, become null and void. Horses registered in partnership or to any business entity shall be nominated by the authorized partner, principal officer or owner of the business entity as registered with AQHA by subscription of \$50 original nomination fee by Sale Entry Deadline, which shall represent the race portion of the sale entry fee and which shall accompany a completed sale entry blank; and to remain eligible for the Futurity: \$150 on or before Dec. 1, 2025; \$250 on or before Feb. 1, 2026; \$300 on or before April 1, 2026 (Horse must be named to Open Berth on or before April 1, 2026); \$350 June 1, 2026; \$400 August 1, 2026, and \$1,000 to enter the trials.

If you are not a current Supporting Member of PCQHRA, you must also include, in addition to any other nomination payments, the sum of \$25.00 as and for PCQHRA Supporting Membership dues. Only the original nominator must be a Supporting Member. Any subsequent owners of a nominated horse are urged to, but not required to, be a Supporting Member of PCQHRA. The tender of any money order, draft, check or other negotiable instrument for any payment due under this nomination is accepted as conditional payment only and is subject to final payment in cash. Any payment returned by the cashing institution as non-sufficient funds shall be assessed a \$50.00 handling charge, in addition to any bank charges. PCQHRA may, but is not obligated to, call the originator of the check and mail a letter to the address on the nomination form (and the name and address on the face of the check, if different) that the check has not been honored and stating the amount needed to reinstate the nomination. All handling charges, plus the payment amount, must be paid by cash, certified check, cashier's check, or money order and be received by PCQHRA within five working days (weekends and holidays excluded) of PCQHRA's written notification or the horse will be removed from eligibility to the race -- no further action will be taken. All race nomination and sustaining payments are refundable if the refund request is made prior to 5 p.m. on the day of the payment deadline for the fee for which the refund is being requested (no 48-hour grace period). Any payment returned to PCQHRA because of stop payment shall result in the nominated horse being automatically removed from eligibility to the race -- no further action will be taken and there will be no refund of nomination or sustaining fees. It is the sole responsibility of the current owner of each eligible entry to make timely payment to maintain eligibility. PCQHRA accepts no responsibility for providing any notice of deadlines or eligibility to any nominator or owner. Any notice provided by PCQHRA is only for the convenience of the nominator or owner. PCQHRA may elect to provide payment reminder notices, eligibility lists or any other notice, but PCQHRA is under no obligation to do so. Failure to mail or receive any notice shall in no way absolve the current owner from ultimate responsibility to ensure timely payment.

The Pacific Coast Quarter Horse Racing Association and/or the Race Track reserves the right to cancel or postpone the race for any reason which it deems good and sufficient. The Association also reserves the right to, at its discretion, transfer this Futurity to any race track situated in the State of California. Nominations or subscriptions to this Futurity may be refused or cancelled without liability, by the Pacific Coast Quarter Horse Racing Association and/or the Race Track at any time prior to the actual running thereof, except for the return of any nomination and entry fees paid.

Nominations to this race do not guarantee a stall for the nominated horse. Stalls are allotted by the Racing Association at whose track this race is to be run. Should stall space be refused, the Pacific Coast Quarter Horse Racing Association and/or the Race Track are obligated only for the return of any nomination fees which have been paid, provided the horse meets all requirements to be eligible for the race. Nominations and sustaining fees will be accepted after the payment deadlines only through the United States mail postmarked (by the U.S. Post Office) no later than midnight of the payment deadline. There shall be an automatic (no penalty) grace period of 48 hours (excluding Sundays and postal holidays) in establishing acceptable postmarks or to hand-deliver a payment to the PCQHRA office. In case of dispute, the only satisfactory evidence of payment shall be a certified mail receipt or a registered mail receipt bearing a United States Post Office postmark on or before the due date.

For all sustaining payments due after a horse has been named to a berth on April 1, 2026 during a period including the 30th day following each payment deadline, any owner may establish/re-establish an entry(s) eligibility by submitting a per entry payment of twice the regular fee due on the prescribed deadline. This 30-day period shall be reduced in cases where the trials for a race are being run prior to the expiration of this 30-day period. In such cases an entry payment of twice the regular fee must be submitted no less than 4 days prior to the running of the trials.

Starters in the trials will be limited to those horses which have started at a recognized American Quarter Horse Association race meeting. These horses must meet the qualification standards as set up by the racing association at whose track this race is to be run and shall be stabled on the grounds no later than the deadline for other horses participating at the meeting. Except as provided herein, there will be no refunds of nomination or sustaining fees for horses which fail to meet any requirement of eligibility.

Change of ownership has no effect on eligibility of the horse as long as all nomination, sustaining, entry fees and all other obligations mandated for eligibility are satisfied.

ELIMINATION TRIALS. The starting field for each trial shall not exceed ten (10) horses. Trials shall be raced under the same conditions as the Futurity. Ten (10) horses shall be selected from the trials to participate in the finals. There will be no also eligible list. All horses starting in the Futurity shall be selected on a time trial basis. If for any reason a tie exists, the horses involved shall draw lots to determine which shall participate in the finals. Should variables exist which would prevent selection based on time trials being accomplished in a fair manner, the Stewards, in their discretion, may then select the finalists based on the horses' order of finish in the trials. Where there is a disqualification, the disqualified horse shall be given the time of the horse behind which the disqualified horse is officially placed plus one- thousandth of a second. In order to ensure that the Futurity and certain other specified races are conducted under conditions that further protect and enhance the integrity and fairness of each race contested at LARC, LAQHRA and the PCQHRA have adopted hair sample testing processes and procedures. Accordingly, all qualifiers (top ten) will be tested by hair and blood, and may at the discretion of LAQHRA and/or LARC be urine tested, within 72 hours after the trials by supervising track veterinarians, utilizing the UC Davis Equine Analytical Chemistry Laboratory. Any qualifying horse having a "positive" test for the presence of Clenbuterol, Albuterol, Zilpaterol, Ractopamine, any other beta-2 agonist, any ARCI Class 1 substance, any HISA S0 substance, and/or the metabolites or analogues of any of these substances, in either a pre- or post-race or out-of-competition test sample, whether conducted under testing authorized by the CHRB or pursuant to a contract between LAQHRA and the PCQHRA, will be deemed ineligible, given a "non-time," and not permitted to start or run in the finals. The decision of the LAQHRA Testing Committee and/or Stewards in all such matters shall be final, and entries are accepted on the condition that those persons nominating and/or starting a horse in the trials or finals agree to abide by the decisions of either or both.

NOMINATOR AWARDS: Nominator Awards of \$10,000 shall be deducted from the total purse of the Futurity. These awards shall be distributed for each race to the original nominators as follows: first: \$5,000; second: \$3,000; third: \$2,000. The individual who makes the first \$50 nomination payment for an Open Berth shall be considered the original nominator and will receive all applicable nominator awards.

PURSES: The trial purses shall not be less than the minimum base purse at the meeting. Trial purses will not be deducted from the added money or nomination or sustaining fees. Trial purses shall be distributed in the same manner as the regular races carded by the track, not to include starter fee(s). FUTURITY - \$50 of each sale entry fee is dedicated to purse money plus added monies, all sustaining and late payments, trial/entry fees and interest.

The purses in both the Futurity will be distributed, after deducting the specified awards and administration expense, as follows: 42% to the winner, 17% to the second horse, 12% to the third horse, 7% to the fourth horse, 6% to the fifth horse, 5% to the sixth horse, 4% to the seventh horse, 3% to the eighth horse, 2% to the ninth horse, and 2% to the tenth horse. If a horse that qualified for the final should be unable to enter due to racing soundness, or scratched for any reason other than a positive drug test or rule violation, the horse shall be deemed to have earned and the owner will receive last place purse money. If more than one horse is scratched from the final, than those purse monies shall be added together and divided equally among those owners. If a qualifier(s) for a final is disqualified for ineligibility or a rule violation after the time trials are declared official but prior to entry for the final, the non-qualifier(s) with the next fastest time shall replace the disqualified horse(s). If a qualifier(s) is disqualified after entry for the final for any reason other than racing unsoundness, illness or death the purse shall be redistributed equally among the remaining qualifiers. Conditions of the race are at all times subject to CHRB rules, regulations and laws.

ADMINISTRATION EXPENSES: Pacific Coast Quarter Horse Racing Association shall receive and retain as compensation, ten percent (.10) of the accumulated funds deposited for this race as and for the cost of administration.
